# Work Plan Winter 2016 / 17 (updated Jan 2017)

# **B9** Folly Meadow

## **Work Party**

- 1. Prune orchard trees (in progress apple trees to be done in February)
- 2. Mark up hazel for coppice, cut and protect cut stumps **Completed** *Gill, Ken, Nicky, Sheila, Gabrielle will work on Orchard needs*
- 3. Clear "new" ditch hand pull bur-reed
- 4. Clear water soldier 75%
- 5. Extend Louise's pond in southerly direction (towards ditch possibly connect with ditch) and use excavated material to raise dip in track.(Completed)
- 6. Winter 2016 dismantling and removing the experimental arable weed plot

#### Management Support Group

- 1 Decide on strategy for "picnic area" including arable weed reserve. Dale leading:-
  - 2017 bouncing ideas for what to do with that area.

# **B10** The Folly (Always consider working The Folly with Rails End) Work Party

- 1. Maintain areas of open grassland by clearance of bramble, scrub, sapling and young tree (oaks) and mowing as necessary (in progress)
- 2. Carry out RA on trees to east of acid grassland with a view to lopping / felling (Richard to take advice from Paul Jackson as to RA need)
- 3. Ensure footpaths are maintained to a high standard and ensure that access is available to as wide a cross section of the community as possible (ongoing action)

#### **Management Support Group**

- Complete interpretation for the Engine Shed. (Sal is liaising with SRT)
- 2. Investigate with English Heritage the possibility of a suitable designation for the remains of the Southwold Railway
- 3. Carry out further cross-sections to log the geological interest

#### Land in non-Green ownership:

- 4. Work with the owners of Castle House on their part of the Folly and, if the opportunity arises in the future, seek to obtain the freehold of the site.
- 5. Pursue the acquisition of Network Rail land including the embankment to the SW of the old railway (between the two railway lines)
- 6. Re-establish the area behind Lark's Rise (Network Rail land) as part of the Folly.

# **B10** Rails' End (Always consider working Rails End with the Folly) Work Party

- 1. Survey all trees to see whether any urgent work is needed for public safety. This should be done in conjunction with our neighbours.

  Richard to take advice from Paul Jackson
- 2. Maintain footpath to provide adequate access to foot traffic. (ongoing action)

#### **Management Support Group**

- 4. Bensly's Drift: sort out our vehicular access currently prevented by padlock
- 5. Pursue replacement of water pumping station prison gates (Holton No 4)
- 6. Survey artefacts: preserve / move historic railway fencing and other materials

# **B11 Angel Meadow**

#### **Work Party**

- 1. Cut selected areas to encourage floral diversity, meadow species, leaving remainder undisturbed (consultation has produced desire for rough areas)
- 2. Make gravel hardstanding around new entrance board.

3. Consider creating an entrance gate / feature at the junction with the Town Park (discussions in progress)

### **B12 Chestnut Meadow**

## **Work Party**

- 1. Remove fences between Meadow and towpath (in progress)
- 2. Remove fences between Meadow and river

#### **Management Support Group**

- 3. agree strategy for Meadow maintenance and upkeep.
- 4. Improve vehicular access (3T restriction on bridge inhibits this)

## **B13** Lester's Piece

## **Work Party**

- 1. Containers: prepare ground, install, fit out, equip. (Ready to receive containers when weather improves)
- 2. Check fence and repair as necessary prior to cows returning spring 2017

#### **Management Support Group**

- 3. Ensure any development proposals address access issues
- 4. Stile, access from Saxon's Way: no right of way here but keep an eye on it

# **B14 Blyth Meadow**

## **Work Party**

- Restore the lock including speaking to Ivan, identifying trees to go this year, price from tree surgeon, we to clear up, treat cut stumps, improve access, interpretation. (in progress – Richard has met with northern bank Land owner)
- 2. Get tree surgeon to pollard willow we to clear up.
- 3. Otter seat reinforce bank, check stile, let in more light, renovate bower.
- 4. Check fence and repair as necessary

# **B15 Two Acres**

## **Work Party**

- 1. Trim hedges along Swan Lane (completed)
- 2. Trim railway hedge to level crossing and clear grass from edge of path (completed)
- 3. Mark up and pollard willows (completed)
- 4. Consider clearing path around wood not sustained in the past. (path cleared)
